Instruction is conducted in both English and Afrikaans but our curriculum is written in English. All assessment & progress reports are prepared in English.

## **CURRICULUM**

We aim to create an environment rich in stimulation, comfort and loving attention, to enhance your child's development. We believe that each child is an individual, and may meet their milestones a little earlier or later than their peers and therefore encourage the baby to develop at their own pace with our guidance and support.

The process of development involves learning and mastering skills like sitting, walking, talking, skipping and eventually tying their own shoes laces. Children learn these skills, known as developmental milestones, during predictable time periods.

Children develop skills in five main areas:

1. Cognitive development (the ability to learn and solve problems)
2. Social and Emotional development (the ability to interact with others and to learn self control)
3. Speech and Language development (the ability to understand and use language)
4. Fine Motor Skill development (the ability to use small muscles, especially the hands and fingers)
5. Gross Motor Skill development (the ability to use larger muscles)

We have different stimulation activities from different sources. Our daily stimulation activities are aimed at achieving these developmental milestones. The parent receives a progress report every 6 months.

### **Curriculum: Junior & Senior (2-5 years)**

Our focus is to develop our toddlers' basic skills. We play and learn while developing movement, sensory and tactile skills. Fun is the key word in all daily activities.

We do not follow a specific curriculum but our educational program is fully integrated with the curriculum and standards set by the Department of Education. The activities are aligned to the subjects and content, concepts and skills for the Curriculum and Assessment Policy Statement (CAPS). Subjects such as science, math, language skills, cultural- and social development as well as art, motor skills and perception are incorporated throughout the year's program.

Our program is based on Christian Ethics. Children are not only taught learning skills, but educated in the values of life.

During our creative activities (art), we strive to develop the child's creativity, thus emphasis is placed on the discussion and exercise and not the final outcome of the artwork. The idea is not to create a perfect artwork, but to focus on the child's development. The end product is therefore less important than the process of creativity, the discussion and the child's enjoyment. (Outcome based teaching).

The program is divided into forty themes throughout the year. We do not teach children to read or write in a formal way, but exercises for preparatory math and writing are included throughout the year.

Our children still have years of formal schooling ahead of them, so we aim at teaching in a playful manner, where they gradually get used to classroom ethics. The lessons and stories are aimed to encourage participation by means of questions and discussions in such a way that toddlers don't even realize that they

## Healthy Eating Plan

We at Miesha Daycare strive to give our children a healthy eating plan. Our menu was planned by a Dietician. (See menu in class). We serve the following meals which are included in the school fees:

Snack	15h00

Please try to bring all children who need to have breakfast at school, before 7h45. Our daily program starts at 8h00 and no breakfast will be served later than this. We have 2 snack days per week, where parents are to provide a small snack box for the 10h00 snack. **No lollipops and chewing gum allowed.**

## Baking

Every Friday we have “Bak en Brou”. This is an expensive activity and there for we ask for each parent to pay R180 per term for Friday Baking. This must be handed in at your class teacher at the beginning of each term, please NO EFT payments for this

## School Fees

Miesha Daycare functions in a 100% private capacity and receives no funds/financial fees from any institution whatsoever

### 1. Please note that school fees are payable for 12 months of the year

#### Important notes:

**School fees are payable over 12 months, charged monthly and payable in advance**

**When school fees are paid upfront for 12 months there will be a discount of 10% on the total amount.**

**School fees are payable during the Public Holidays, in the event of illness and during December & Easter school holidays.**

**School fees will be revised annual and the increase will be effective 1 January of each year, and the increase will be communicated in writing two months prior to the increase date.**

### 2. Deposit and registration fees:

**A deposit of equal to one month's fee** is payable upon signing of the contract. No interest is payable on the deposit amount and **is not refundable** in any way.

Refer to point 3 below for notice of withdrawal.

**A registration fee of R600 per family is payable upon enrollment, and thereafter annually in January of each year. The registration fee is not refundable in any way.**

No child will be allowed to attend school without these fees paid first.

### 3. Notice of withdrawal:

**One calendar month (i.e 1-31 March) written notice is required, except when notice is given on 1 October, in which case four (4) calendar months written notice is required i.e. October, November, December, January. Please note 1 October is the last date on which notice can be given for the year. Notice cannot be given during November and December and January months. Notice must be given before the 15<sup>th</sup> of a specific month for the end of the following month(i.e before 15 July if child is to leave end of August)**

Full payment for the notice month(s) will still be made; the deposit will be kept as payment for the **last** month if all fees are paid up to date and if full notice is given as per rules and regulations, unless agreed upon by the sole discretion of the owner.

### 4. Non-payment:

Should a parent default on payment, there will be a penalty fee of **R150 per day** and the cost of debt collecting may be added to the outstanding amount.

## GENERAL INFORMATION

### 1. Documentation required for enrollment:

- Signed and completed application forms
- Signed rules and regulations
- Copies of both parents' ID's
- Copy of child's immunization card
- Copy of child's medical aid card
- Copy of birth certificate
- Proof of address

### 2. Closing during public and school holidays:

- The daycare will be closed on all South African public holidays.
  - Miesha Daycare closes every year during the last week before Christmas and will re-open on the **2<sup>nd</sup> week in January. Normal school fees are payable during December & January**
  - Miesha Daycare reserves the right to close for a maximum of 5 ADDITIONAL days throughout the year**, depending on the public holidays of that specific year. These dates will be communicated to the parents well in advance.
- Miesha Daycare will also be closed for **7 working days during the June/July school holidays**. This will also be communicated in advance.

### 3. Health Policy:

Please refer to our attached Health Policy for detailed information. To assist the daycare in containing the spread of infectious diseases, we ask that you refrain from sending your child to daycare in any of the cases mentioned in our policy. The daycare reserves the right to refuse entry to any child with such symptoms, and to call the parents in a case where the child becomes ill during the day.

### 4. Security

- Please ensure that the gate is always closed behind you when entering the premises.
- Please inform your child's teacher in advance if anybody other than yourself will be sent to collect your child. We will require such person to sign our collections book, and too produce valid identification on arrival at the daycare before we will release the child in his/her care.
- Please do not let any child unaccompanied by a parent out of the premises.

### 5. Liability and indemnity

Miesha Daycare assures all parents that it is our top priority that your child is safe and secure whilst on our premises and in our care. Please ensure that your child is personally handed over to a staff member on arrival.

The owner or personnel cannot accept liability in case of any of the following:

- Any injury your child may suffer while in our care.
- Any loss of property.

□ The parking facilities and driveways are used at your own risk, Miesha Daycare cannot accept responsibility for any injury or damages that may occur to person or property in this area.

I/we also take note that Miesha Day Care Center is now registered with the Department of Health but is still busy with the registration at Social Development. The department of Health & Social Services visits the school on a regular basis and we are in tact with all the regulations set out by both DSD & DOH

## Health Policy

A Daycare is a wonderful place for young children to learn and thrive in. It is, however, also an ideal environment for germs to grow and be passed on from child to child. In order to safeguard our children from recurrent illnesses, as best as possible, certain guidelines need to be adhered to.

These are:

Children with potentially infectious diseases must be kept at home. (Below are some examples of infectious childhood diseases which will not be allowed at school. Please note that this list is by no means comprehensive).

If a child becomes seriously ill while they are attending school the parent will be informed and asked to fetch the child immediately, **this includes fever higher than 37.5 degrees and if they have more than TWO watery stools. We can not give a sick child all our attention as needed and not attend to the other children in the class.**

It is the parent's responsibility to be contactable at all times in case of emergency, or to make adequate arrangements for a named adult to be available in their place. The school must be made aware of such person's contact details upon enrolling the child. If none of the contactable people can be reached, Miesha Daycare will then make a decision on the urgency of the matter and may phone an ambulance.

Any medicine sent to school must be clearly marked with the child's name and dosage instruction, and documented in the medicine book (or a note with instructions must be attached) in the classroom before handing it to the teacher to be placed in the medicine cupboard or refrigerator. Furthermore, it remains the parent's responsibility to remove the medicine from the box or refrigerator at the time of going home. **No antibiotics will be administered at school.** If any medicine is found in a child's bag it will be confiscated.

Biting incidents: if a child is bitten while at school, the parents will be informed telephonically if the skin is broken. It is the parent's responsibility to take their child to the doctor and obtain treatment. If the skin is not broken the parents will be informed when they collect their child as it is unlikely that any immediate treatment is necessary.

## **Common infectious diseases**

### **Chickenpox**

Recognised by an itchy rash which forms small red spots which eventually turns into blisters. It usually begins on the body and then moves to the face. Chickenpox is contagious 1-2 days before the onset of the rash, and until all the lesions have formed crusts. *CHILDREN MAY ONLY RETURN TO SCHOOL WHEN ALL THE LESIONS HAVE CRUSTED OVER.*

### **Conjunctivitis**

Commonly called pink eye, conjunctivitis is an inflammation of the thin, transparent membrane that covers the whites of the eyes and lines the eyelids. In bacterial infections yellow, sticky pus is seen in the corners of the eyes. In allergic cases the discharge is clear. Bacterial conjunctivitis is highly contagious and hence should be treated with antibiotic eye drops *AT HOME UNTIL THE PUS* has completely disappeared.

### **Diarrhoea & Vomiting**

If a child has persistent *LOOSE WATERY STOOLS AND/OR VOMITING HE/SHE SHOULD BE KEPT AT HOME.* Even with good hygiene measures such as hand washing after nappy changes, mopping of floors etc; the illness is easily spread to other children in the facility. Furthermore the staff is not able to deal with the care of a vomiting child as well as their normal duties. When a child has 4 more watery stools the parents will be contacted to come and fetch the child immediately.

### **Head Lice**

Head lice are small, flat, wingless insects that infest the hair on the human head. The symptoms are intense itching, tiny red spots on the scalp and small pearly white eggs covering the roots of the hair. Special head lice shampoos and nit combs can be obtained from the chemist. The rest of the family must be treated and the child will *ONLY BE ALLOWED BACK AT SCHOOL AFTER SUCCESFULL TREATMENT OF BOTH THE LICE AND THE NITS.*

### **Impetigo**

This is a bacterial infection that is most commonly seen around the lips, nose and ears. The characteristic rash starts as small blisters, which then break and crust over to become yellow-brown scabs. Although not serious it is highly contagious and must be treated with an antibiotic or antiseptic cream. The child *SHOULD STAY AT HOME UNTIL THE INFECTION HAS CLEARED.*

### **Measles, Mumps and Rubella**

All 3 illnesses are highly infectious but preventable by immunization. Isolated cases can still occur and must be diagnosed and treated by a doctor. No children with *UNIDENTIFIED RASHES OR HIGH FEVERS WILL BE ALLOWED TO COME TO SCHOOL UNTIL DIAGNOSED BY A DOCTOR OR FULLY RECOVERED.* A doctor's letter must accompany the child when back at school.

## **COVID**

Child **MUST** be kept at home if any of the signs of Covid are present. If any of the parents (or anyone living with the child in the same house) have these symptoms, child **MUST** be kept at home until it is proven that child or parent is testes negative (a letter from doctor is required to confirm this)

**COVID-19 affects different people in different ways. Most infected people will develop mild to moderate illness and recover without hospitalization.**

**Most common symptoms:**

Fever (anything above 37.4 the child will not be allowed to enter the school premises)

dry cough

tiredness

**Less common symptoms:**

aches and pains

sore throat

diarrhoea

conjunctivitis

headache

loss of taste or smell

a rash on skin, or discolouration of fingers or toes

**Serious symptoms:**

difficulty breathing or shortness of breath

chest pain or pressure

loss of speech or movement

Immediate medical attention must be obtained if you have serious symptoms.

Children with mild symptoms who are otherwise healthy should be managed at home until symptoms are gone.

On average it takes 5–6 days from when someone is infected with the virus for symptoms to show, however it can take up to 14 days.

**Take Note;**

**Miesha Daycare must and can close at any time for a maximum of 5 working days if any staff member is diagnosed with COVID.**
